1 Scope

- 1 These General Terms and Conditions apply between the

an association established under Swiss law (hereinafter “the Committee”), and all natural persons and legal entities that make donations via the www.unicef.ch website (hereinafter “the Donor”).

- 2 The GTC apply in the version that is valid on the date on which the donation is transferred.
- 3 The Committee’s General Terms and Conditions apply exclusively. By transferring their donation, the Donor explicitly acknowledges the General Terms and Conditions. Contrary conditions or conditions of the Donor that deviate from the Committee’s General Terms and Conditions are not recognized, unless accepted by the Committee in writing in a specific case.
- 4 The Committee reserves the right to amend these GTC at any time.

2 Subject and conclusion of contract

- 1 The Donor makes a once-off donation to the Committee of the amount selected or entered by them in the input screen.
- 2 The contract regarding the donation is established by the transfer of this amount.

3 Use of donation

- 1 The Committee is generally authorized to make free use of the donation in compliance with the association’s purpose (non-specific donations). The Committee generally uses non-specific donations for emergency relief, underfunded countries, reconstruction projects or the further development of the organization. Non-specific donations are not subject to any other terms or conditions. The donation does not grant the Donor any right to claim support for specific projects or any other rights.
- 2 If the Donor makes a donation for a specific purpose as described on a sub-page of the www.unicef.ch website (or a donation for a specific project, program or emergency supplies), the Committee uses the donation as described on the relevant sub-page (specific donations). If it has good cause based on objective arguments, the Committee is authorized to use specific donations in the same manner as non-specific donations. Examples of good cause include the discontinuation of projects or programs, or mistakes made in communicating the purpose of the donation on the sub-page.

4 Payment means and methods

The Committee accepts the following means of payment:

- Credit cards: Mastercard, VISA
- Direct transfer via PostFinance
- TWINT
- PayPal
- Account details provided by email

5 Correction of input errors

Input errors made when manually entering the donation amount must be corrected within seven days of their discovery. The option to correct input errors lapses one year after the transfer of the donation. Correction requests must be sent in writing to:

6 Taxes and duties

- 3 According to the applicable Swiss tax legislation, donations made to the Committee in Switzerland and Liechtenstein can be deducted for income tax purposes under certain conditions. The Committee does not, however, give any guarantees regarding the tax deductibility of donations. Donations already made may not be revoked owing to the fact that they are not tax-deductible.
- 4 For donations of 20 francs or more, Donors receive a donation receipt from the Committee the following January.
- 5 If, contrary to expectations, the Donor should be required to pay taxes or duties on a donation, these taxes and duties have to be borne by the Donor.

7 Data privacy

- 6 The data required for the processing of the transaction are stored in compliance with the applicable provisions. Further information on how we handle your data can be found in our [Data privacy policy](#).
- 7 The Donor has the right at all times to receive information free of charge about their stored data as well as to the rectification, blocking and erasure of their stored data. Please send an email to info@unicef.ch or submit your request to us by post or fax.

8 Applicable law, place of jurisdiction and miscellaneous

- 8 Swiss law applies exclusively, without regard to any provisions on the conflict of laws.
- 9 Zurich is the exclusive place of jurisdiction for all claims relating to donations.
- 10 The ineffectiveness of individual provisions do not affect the validity of these GTC as a whole.
